SUBDIVISION REVIEW COMMITTEE MEETING APRIL 2024:

The Columbia County Subdivision Review Committee Meeting was held on Thursday, April 11, 2024 at 8:30 AM with Paul Lee and Terry Hoover present. At this meeting a total of thirteen (13) Review and Approval Applications and four (4) Review and Comment Applications were reviewed. The following comments are offered:

There were six (6) applications the Review Committee felt required No Action. These were:

#109 (2022)—Main Township Board of Supervisors, Main Township, 1 lot, 05 acres, (Land Development) There are numerous outstanding items on this application.

#75 (2023) – Biros, Michael & Kimberly, Beaver Township, 1 lot, 0.06 acre (Land Development) There are numerous outstanding items on this application.

#86 (2023)—Beach, Margaret & John, Franklin Township, 1 lot, 5.9 acres There are numerous outstanding items on this application.

#11—Thomas, Mary, Cleveland & Franklin Township, 1 lot, 5.85 acres There are numerous outstanding items on this application.

#18—Catawissa Borough Municipal Authority, Catawissa Township, 1 lot, .44 acres (Land Development) There are numerous outstanding items on this application.

#25—Swilp, Matthew John and Yana, Beaver Township, 1 lot, 30 acres There are numerous outstanding items on this application.
