Matt also highlighted the fact that section 8 housing in the County has a 2 ½ year wait period. The ESG grant is for \$275,000 and has a 10% administration built into the amount. Geralee then discussed item E on the agenda which is the letter of application and authorization to enter for the elevation certificates for the Benton Area. Jean then reviewed bills and available cash. After reviewing the reaming agenda the work session was then adjourned.
