There was a Commissioners meeting at 2:00 PM in the Commissioners Conference Room at 700 Sawmill Road, Small Conference Room for the regular scheduled Commissioners meeting. In attendance were Commissioners Ridgway, Young, and Kovach, Solicitor McDonald, Chief Clerk Witchey, Michele Frye, Jean Lapinski, and Marcie Strachko. Via zoom were the following individuals April Miller, MJ Mahon, Jodi Cook, Don Coleman, and Jennifer Long.

Commissioner Ridgway called the meeting to order and asked that we stand and pledge the flag, he then called for the approval of the minutes of the prior meeting.

Commissioner Ridgway then called for a report of the work session: There was a 10:00 work session held. In attendance were Commissioners. Commissioner Ridgway asked CMSU to start the meeting by discussing how they intend to utilize the opioid settlement money that the County is going for forward to them. Patricia stated the funding would be used for program expansion which includes following the patient through the entire process. She also indicated that they were going to lose some grant money which was 500k but that would not affect the service provided to Columbia County residents. The extra funds would go towards more comprehensive services which also would include a Certified Recovery Specialist. Geralee from SEDA-COG also provided an update on the Benton Elevation and M&E Program, she confirmed to date that there are 25 application for elevation of machinery and equipment and 15 elevation certificates requested. She also indicated that if more applications come in we could do a 3rd round for consideration. Commissioner Young then discussed the Benton Foundry Metal Caster of Year Award and stated that the Foundry is a "gem" of the area, Commissioner Kovach then stated that there are 1,725 plants in the US and they employ over 490,000 employees and to receive such an award is very prestigious. Jean then reviewed cash and accounts payable and then the rest of the agenda was reviewed which included Marcie reviewing all personnel moves after which the work session was adjourned.
