August 4, 2022

There was a Commissioners meeting at 2:00 PM in the Commissioners Conference Room at 700 Sawmill Road, Small Conference Room for the regular scheduled Commissioners meeting. In attendance were Commissioners Young, Ridgway, Kovach, Chief Clerk Witchey, Marcie Strachko, Michele Frye, April Miller, Jean Lapinski, Misty Chapman, and Denise Labuda. Via zoom: Don Coleman, MJ Mahon, Jen Long, and Sheriff Chamberlain.

Commissioner Young called the meeting to order and asked that we stand and pledge the flag, he then called for the approval of the minutes of the prior meeting.

Motion by Kovach, seconded by Young; motion passes.

Commissioner Young then called for a report of the work session: There was a 10:00 work session held. In attendance were Commissioners Young, Ridgway, Kovach, Solicitor McDonald, Chief Clerk Witchey, Marcie Strachko, Michele Frye, April Miller, Misty Chapman, Tyler Nichols, Wade Mays, Jean Lapinski, Richard Phelps, Rich Kisner, Eddie Ranum, Matt Hess, Betsy Rubio and MJ Mahon. Via Zoom were the following individuals: Don Coleman, Sheriff Chamberlain, Tim Murphy, Alex Karpinski, Jen Long and Jeremy Brown. Commissioner Young called the work session to order and asked that ABM discuss the two items on the agenda. The first being the Resolution approving the implementation of the design to build project to address infrastructural need of the County and the selection of Prime Capital Funding as the lessor of the project at 3.75%. Tyler started the conversation reviewing the project and stating five (5) banks provided rates for the loan. Prime Capital was the lowest rate and had no issuance fee. Commissioner Ridgway asked about paying the loan off early and Tyler stated that there is a sliding scale from a 3% to 1% penalty. At that time Commissioner Ridgway that he wanted to do the project but wanted to delay the decision to the next Commissioner's meeting. After some additional comments and brief discussions regarding the ABM projects, Commissioner Young asked Rich Kisner to discuss his item on the agenda. Rich stated that the USDA had a program called Rural Placemaking Innovation Challenge Grant. He said that he would like to pursue this grant and would use Hailstone as the Consultants if he able to receive the grant. The grant is a quality of life for the residents of the County, which includes broadband and many other items. The total grant funds are \$20 million but Columbia if selected would only receive a small portion of those funds. Rich did feel that the County would have a strong application in that there has never been one given in Northeast Pa. Children & Youth Director April Miller discussed their item on the agenda which is their annual public hearing for the proposed 2023/2024 budget. Jean then reviewed available cash and cash comparison from LY to CY and also reviewed the bills from 8-5-22. The rest of the agenda was reviewed, Marcie discussed the hires/step/promotions and then the Salary Board agenda were reviewed and the work session was adjourned.
