

# STIPULATION TO ALTERNATIVE PLAN OF REPAYMENT AND MODIFICATION OF STAY IMPOSED BY SECTION 362 OF THE BANKRUPTCY CODE

This Stipulation is made this <u>28th</u> day of <u>March</u>, 1991, by and between Northeastern Bank of Pennsylvania ("NEB"), through its attorneys, Rosenn, Jenkins & Greenwald; Charles R. Shotwell, Jr. and his wife Linda B. Shotwell ("Debtors"); Joseph J. Heston, Esquire, Trustee, all of whom agree as follows:

- 1. On November 14, 1990, the Debtors filed a petition under Chapter 13, Title 11 of the United States Code, and an Order for Relief was thereafter entered by the Court.
- 2. On December 5, 1985, Debtors, individually and on behalf of University Real Estate Co. ("University"), executed and delivered two notes ("Notes") to NEB, one of which was in the amount of \$130,000,00 and the other of which was in the amount of \$10,000.00. True and correct copies of the Notes are attached as Exhibit "A".
- 3. The Notes are secured by a mortgage, dated December 5, 1985 ("Mortgage"), on, inter alia, certain real estate owned by the Debtors which is more fully described as the real property located at 637 Catherine Street, Bloomsburg, Columbia County, Pennsylvania ("637 Property"). A true and correct copy of the Mortgage is attached as Exhibit "B".

- 4. The Mortgage was properly recorded in the Columbia County Recorder of Deeds! Office at Book No. 358, Page 609 and constitutes a first lien on the 637 Property.
- 5. Debtors are in default of their payment obligations under both the Notes and the Mortgage and have made no payments to NEB since September 30, 1986.
- 6. Debtors and NEB have previously stipulated and agreed, and do hereby reaffirm, that the fair market value of the 637 Property is \$67,000.00.
- 7. Debtors and NEB have reached an agreement on the terms of a payment plan to allow Debtors to retain the 637 Property, and these terms are as follows:
- (a) Upon the signing of this Stipulation, Debtors' shall immediately pay, to NEB, \$3,000.00;
- (b) Thereafter, Debtors shall make payments of \$1,500.00 per month to NEW for 54 consecutive months, beginning March 24, 1991, and one monthly payment of \$151.72 on September 24, 1995;
- (c) Each monthly payment must be received by \*\*\*\* on or before the 24th day of the month in which the payment is due;
- (d) Debtors monthly payments shall be allocated to interest and principal as specified on Schedule A which is attached hereto:
- (e) Debtors shall make all payments to NEB in the form of cash or certified check; failure to make payment to NEB in cash or a certified check shall be a default under this Stipulation;
- (f) Debtors may prepay their obligations under this Stipulation in full, at any time, but only if they have not committed any default or breach of any term or condition this Stipulation;

- (g) In order to prepay their obligation in full, Debtors must pay to NEB, in cash or a certified check, the amount listed as the "Balance Due" on Schedule A, as of the date of the Debtors' last monthly payment;
- (h) Upon payment of the amount specified in subparagraph (g), or upon the successful completion of all of the monthly payments as provided in this Stipulation, NEB shall release the 637 Property from the lien of its Mortgage;
- (i) All payments contemplated under this Stipulation are to be made the Trustee outside of the Debtors' Chapter 13 Plan and shall be paid directly to HEB; and
- (j) Debtors shall maintain insurance, in accordance with the terms of the Notes and Mortgage, on the 637 Property during the period covered by this Stipulation.
- Debtors understand and agree that if NEE has not received any monthly payment within four (4) days from the date the payment was due; if Debtors fail to make any payment in the form of cash or a certified check; or if Debtors default or breach any of the other terms or obligations contained in this Stipulation, NEB reserves the right, at its option and without limitation or exclusion, to: (a) accelerate the maturity of the Note; (b) declare the entire remaining unpaid balance under the Note or, alternatively, under this Stipulation to be immediately due and payable, without notice or demand upon debtors; (c) immediately proceed with an action in mortgage foreclosure; or (d) exercise any of its other remedies in accordance with applicable state law.
- 9. Further, if the Debtors commit default or breach of any term or condition of this Stipulation, then the lifting of the automatic stay pursuant to 11 U.S.C. §362(d) shall be self-executing without the necessity of any further action by NEB under the provisions of the Bankruptcy Code.

- 10. Debtors hereby waive the right to obtain a discharge, under any Chapter of the Bankruptcy Code, in any subsequent bankruptcy proceeding that they may file within six (6) years from the date that this Stipulation was executed.
- 11. NEB's entry into this Stipulation shall not constitute a waiver or an abridgement of its right to contest the Debtors' eligibility to be debtors under Chapter 13.


